Virtual Assistant 'Angie' now Serving You

On January 25, 2024, LAFCU began enhancing every member's web and phone experience by going live with Angie, our 24/7 virtual assistant. She has been programmed to answer many frequently asked questions and help conduct simple transactions.

You can chat with her 24/7 from our website and speak with her when calling us:

- To chat, visit our website, click the Angie avatar on the lower right of each page, then type your questions and get replies in the chat window.
- To speak with her, call (877) 695-2328 (MY LAFCU) and she will answer your spoken questions.

On the phone, Angie can securely help you 24/7 with your account, such as providing balances & history, making transfers & loan payments, and reporting fraud.

Here are useful ways you can communicate with Angie when calling us:

- Use just a few words to ask each question.
- Say "repeat," and Angie will repeat her prior response.
- Say "slow down," and Angie will speak slower for the rest of the call.
- Say "speak faster," and Angie will speak faster for the rest of the call.
- Say "hold on a sec," and Angie will stop speaking until you resume talking.
- If Angie cannot answer a chat or spoken question, she can transfer you to a live agent (when one is available) if you say: Agent, Representative, Help, Contact Center, or Something Else.

Student Scholarship Entries Accepted until April 15



We are still accepting applications from LAFCU members until April 15, 2024 for the 2024 Jack C. Mathews College Scholarships. High school seniors & graduates, college students, or graduate students with a 2.5+ GPA who have been accepted and plan to attend or are attending a college or trade school in the fall of 2024, either on-campus or remote, are eligible. We will award \$2,500 each to four students (\$10,000 total).

This year, instead of an essay, applicants must create and submit a 60-second-long maximum length VIDEO that creatively answers this question: "What will you do with the \$2,500 scholarship if you are one of the winners?" You must be a LAFCU member in good standing to apply for a

scholarship. If you are not yet a member and under age 18, ask your parent or a guardian to open your membership prior to submitting an application. For the application and rules, visit our website and search "scholarships."

Habitat for Humanity Charity Fundraising in April



In April, LAFCU will partner with the San Gabriel Valley Habitat for Humanity (HfH) to raise funds and awareness to help families in need of decent, affordable housing. Founded in 1976, HfH is a global nonprofit housing organization that provides homes for deserving families. LAFCU has a goal to raise \$5,000 for this charity, and for every dollar raised, we will match up to \$5,000 through our 501(c)3 nonprofit charity, the Los Angeles Charitable Association, Inc. (LACA). Later in May, some LAFCU employees will volunteer their time to help build a 4-plex for HfH in Azusa.

Through LACA, LAFCU is committed to financially supporting other 501(c)3 charities in the Greater Los Angeles, California Metropolitan area. Since its founding in 2006, LACA has donated over \$650,000 to other deserving charities and will continue to do so.

Funds for Habitat for Humanity will be raised from online and in-person branch donations. A special giveaway (while supplies last) will be offered to members who donate \$20 or more in one of our branches. Visit our website for details.

- Options include opening a \$100 minimum "Starter" Share Savings Certificate, and on approved credit, maximum \$1,000 credit line Visa® Credit Card or \$1,000 Personal Loan, and \$20,000 no-money down vehicle loan

Student/parent education loans are also available and are serviced by our partner, cuScholar Private Loans. With financing from \$2,000 to \$120,000 (for undergraduates) and \$160,000 (for graduates) per year, terms up to 120 months, no origination fees, and competitive fees, and competitive student loan interest rates, these loans can help you fill in the funding gap between the associated costs of attending school and the amount that federal loans, grants, and scholarships cover.

Preventing Your Account From Dormancy

If your LAFCU account has been inactive for 12 months, it's legally considered "dormant." Then, upon no member-initiated activity for 18 consecutive months:

- The account will be charged a monthly \$3 inactive account fee
- Under California law, your funds could be turned over ("escheated") to the California State Controller Unclaimed Property Division.

To prevent these events from happening:

- At least annually, make at least one deposit, withdrawal, or transfer from your account.
- At least annually, use your LAFCU Visa® Credit Card and make a payment to it from your LAFCU Share Savings or Checking account.
- Set up Direct Deposit to your account from any recurring deposit.
- Notify LAFCU whenever you move or change telephone numbers or email.
